GREAT DECISIONS IN SALT LAKE CITY – 2015

The Salt Lake City Great Decisions Group will be meeting this year at **Sprague Library, Wednesday afternoons from 1:30 until 3:00 p.m., beginning February 11.** The study program will last for 8 weeks. Great Decisions, a community-based program of the Foreign Policy Association, provides a way for us to learn about current world issues and problems. Each member of a study group uses a study guide that presents the topics and provides questions for discussions. Members of the group lead the weekly discussions. In addition, the meeting begins with members watching a video discussion of each topic.

The Briefing Book places the thematic or geographic issue in historical context and provides background, current policies and alternative policy options. Photographs, maps, charts and editorial cartoons illustrate the text. Discussion questions, annotated reading suggestions and additional resources, including websites, are provided. An opinion ballot for the National Opinion Ballot Report

The video comprises a discussion with experts on each topic, usually presenting different views, in addition, to featured guests.
